2. No overstay of purchased Package permitted. Passenger's who overstay the package purchased, have a high risk of being charged a penalty in Saudi Arabia and possibility of missing their flight home. Al Haramain Hajj & Umrah Services will not be responsible for these penalties. See Legal Notice at the bottom of this page for further information.
3. Approvals that come from the Ministry of Hajj by website will automatically be cancelled after two weeks from the approval date if visas are not issued within the two weeks period
4. Approval charges \$75/person non-refundable once approval proceeds.
5. First Entry/Exit into Saudi Arabia (for Umrah) MUST be from Jeddah (not Riyadh/Dammam)
